**Allegiant Air Announces Nonstop Service to Plattsburgh, New York from Orlando Sanford
New Service Opens Up Canadian Market for the Airport**

Sanford, FL, November 20, 2007 – Allegiant Air and Orlando Sanford International Airport (SFB) announced today scheduled, nonstop, low-fare service beginning February 1, 2008 to Plattsburgh International Airport (PBG), in Upstate New York. Just one hour south of Montreal, the airport is conveniently located off New York's Interstate-87, on beautiful Lake Champlain serving as "Montreal's U.S. Airport". The Olympic village of Lake Placid is also less than an hour's drive offering you world-class recreation and relaxation year round. Allegiant Air is offering introductory fares as low as \$89* each-way, when booked through the company's website at www.allegiantair.com.

Service will operate twice weekly on Monday and Friday. Flights will depart Orlando Sanford at 3:20 p.m. and arrive at Plattsburgh at 6:25 p.m. Return service will depart Plattsburgh at 7:00 p.m. and arrive in Orlando Sanford at 10:10 p.m. (all flight times are local). Allegiant will utilize 150-seat, MD-80 series jet aircraft on the route.

"We are extremely pleased to expand the Allegiant brand of low-fare, nonstop jet service to the North Country and Canadian residents," Maurice J. Gallagher, Allegiant Air president & CEO, said. "This is an exciting new addition for our airline and our customers as we launch the only nonstop, air service between Plattsburgh and Orlando."

According to Airport President, Larry Dale, "The addition of Plattsburgh signals a long-awaited return of service to New York State from Orlando Sanford. We fully anticipate that Plattsburgh will emerge as one of our most popular destinations."

Allegiant's \$89* one-way introductory fare is limited, not available on all flights and must be purchased by December 15, 2007, for travel through May 15, 2008. After the introductory fare period, regular one-way fares on the route start as low as \$109 one-way. Plattsburgh is one of 28 nonstop destinations for Allegiant from Orlando Sanford.
